

**Electric Rate Schedule EV-D
Residential Service, Time-of-Use Option**

Applicability

This is an optional, pilot, Time-of-Use (TOU) Rate applicable to individual family accommodations devoted primarily to residential customers and who have a currently registered Motor Vehicle, as defined by the California Motor Vehicle Code, which is: 1) a plug-in battery electric vehicle (PBEV) or plug-in hybrid electric vehicle (PHEV) recharged via a recharging outlet at the customer’s premises.

Character of Service

Alternating current at a frequency of approximately 60 Hertz: 120 volts, 120/208 volts or 120/240 volts, single phase, as specified by the District. Three phase service may be specified and supplied by the District at its option for residential heating and/or air conditioning loads.

Monthly Charges

The total amount of a customer’s bill, excluding applicable local and state taxes and surcharges, will be the sum of the charges listed below and any adjustments for Special Provisions, effective on the date of meter reading for each account.

Territory Served

The entire area within the Modesto Irrigation District electric service boundary or any other area served by Modesto Irrigation District pursuant to the laws of the State of California and the District’s Electric Service Rules.

Time Periods

Time periods are defined as follows:

Winter: (Service from October 1 through April 30)
 On Peak: 5:00 p.m. to 8:00 p.m. Monday through Friday, excluding holidays.
 Partial Peak: 1:00 p.m. to 5:00 p.m. and 8:00 PM to 11:00 PM Monday through Friday, excluding holidays.
 Off Peak: All other hours

Summer: (Service from May 1 through September 30)
 On Peak: 5:00 p.m. to 8:00 p.m. Monday through Friday, excluding holidays.
 Partial Peak: 1:00 p.m. to 5:00 p.m. and 8:00 PM to 11:00 PM Monday through Friday, excluding holidays.
 Off Peak: All other hours

Holidays are: New Year’s Day, President’s Day, Memorial Day, Independence Day, Labor Day, Veterans Day, Thanksgiving Day, and Christmas Day.

Special Provisions

1. Availability

Service under this Rate Schedule is available the first of the month following customer’s selection. Once this Rate Schedule is selected, customers subsequently requesting a transfer from the Optional Time-of-Use Rate to the Standard Rate may not return to the Optional Time-of-Use Rate for a 12-month period. Cancellations become effective at the end of the billing cycle in which notice for cancellation is received.

2. Data Loss

In the event of data loss where the District is unable to determine in which time period the kWh were consumed, the kWh will be placed in the Off-Peak period.

3. Initial Read and Final Read

Service Connects and Disconnects will use the previous day's midnight reading as the start/stop read.

4. Rules and Regulations

Service under this Schedule is subject to the District's Rules and Regulations for Electric Service as they may be amended from time to time.

5. Experimental rate

The General Manager has, at their sole discretion, the right to suspend, modify, restrict and/or close this experimental rate schedule at any time.
