



Am I eligible for STEP?

You are eligible if you have a residential central air conditioner. You are not eligible if you have

- an evaporative (swamp) cooler, or
a window or wall mounted unit.

How does STEP work?

MID installs a small "load control" device on your air conditioner. When STEP is needed, MID will signal your air conditioner to cycle off. Cycling does not harm your air conditioner. Overall power usage is reduced through the controlled cycling of thousands of air conditioners.

How long will my air conditioner be off?

When STEP is used, your air conditioner will be cycled off up to an average of 10 minutes each half-hour. Most people never notice when the STEP device is working. This time off should not increase the temperature inside your house.

Where does my STEP credit show up?

The \$5 per month, May through September, bill credit shows up on your monthly MID electric bill.

When will this device be installed?

STEP devices will be installed during 2007. You will not need to be at home for the installation since the device is attached to the air conditioner on the outside of your home or apartment. Information will be left for you when the device is installed. The first 500 valid applications are expected to have STEP devices installed. All other applications will be placed on a waiting list.

How do I get in STEP?

Fill out the application below, cut it off and return it with your MID payment, or in a separate envelope with postage to: MID Energy Management Department, P.O. Box 4060, Modesto, CA 95350-4060. Or bring it in to the MID office, 1231 11th Street, Modesto, between 8 a.m. and 5 p.m. Monday through Friday. Or place it in the drop box on 11th Street in front of the MID, available at any time.

STEP is voluntary and you may cancel at any time.

Renters may participate with a landlord's signature on the STEP application.

Air conditioning equipment must have an accessible mounting location as determined by the installer. The installer may determine that installation is not possible due to the condition of the air conditioner.
