

Applicability

This Schedule is applicable to small, constant, non-metered incidental loads for utilities, communication agencies, state agencies, and applicable special districts where the customer owns and maintains the equipment. The customer must supply equipment wattage to the District. Such loads would include:

- Cathodic Protection Stations
- Motor Radial Gates
- Pressure Point Automatic Watering Systems
- Flashing Beacons
- Sign Illumination
- Communication Power Booster Devices

Character of Service

Energy will be supplied at 120/240 volt single-phase service. Load must be tested by the District and verified that it does not exceed 2000 watts.

Territory Served

The entire area within the Modesto Irrigation District electric service boundary or any other area served by Modesto Irrigation District pursuant to the laws of the State of California and the District’s Rules and Regulations for Electric Service.

Term

2. Termination of Service

Upon termination of service, the District shall have the right to remove all of its facilities placed, installed, erected or used in supplying services hereunder.

3. Rules and Regulations

Service under this Schedule is subject to the District's Rules and Regulations for Electric Service as they may be amended from time to time.
