TERMS AND CONDITIONS

Each of the undersigned declares under penalty of perjury that:

1. The above-mentioned solar system:

- a. Is designed to offset all or part of the customer's annual electrical needs. System sizing not to exceed 115% of customer's annual demonstrated load (See MID Net Energy Metering Interconnection Handbook for details.)
- b. Is located on the customer's premise and within Modesto Irrigation District's (MID's) service territory.
- 2. The customer acknowledges that no MID incentive is available for the installed PV system.
- 3. A **non-refundable \$300** Interconnection fee shall be required (see MID Electric Service Rule 21 Appendix A) for systems of less than 100 kW AC-CSI rating. Systems greater than 100 kW AC-CSI rating shall require a non-refundable **\$800** Interconnection fee (pursuant to MID Electric Service Rule No. 21 Appendix A).
- 4. Applications that are over one year old (from the date of the District's acknowledgment) are subject to cancellation by the District; however, the District will not cancel an application if reasonable evidence that the project is still active is provided.
- 5. The customer agrees to grant MID access to the customer's property for the purpose of on-site inspection(s) to verify that the site and installed equipment are as stated.
- 6. MID is NOT party to the installation contract between the customer and contractor/vendor. MID does not warranty or in any way guarantee the quality of the PV equipment. Acceptance of such is the customer's responsibility. MID is not responsible for any Tax Liability associated with the receipt of any Utility, State, or Federal Government offered Rebate(s). The customer shall comply with all city and/or county ordinance(s) and obtain all required city and/or county permits.
- 7. The customer has read, understood, and agreed to the program requirements as stated in the MID Net Energy Metering 2.0 Interconnection Handbook.
- 8. The information on this form is true and correct to the best of their knowledge.
- 9. Customer and contractor acknowledges the installation of a solar system and/or energy storage device(s) will not eliminate a monthly bill from MID under the NEM 2 program.
